- Behavioral Health Information Notice (BHIN) <u>25-019</u> released in May 2025 outlines requirements under SB923 for providing trans-inclusive health care for individuals who identify as transgender, gender diverse, or TGI.
- > SAPC IN: 24-02 Requirements for Culturally and Linguistically Appropriate Services
- Intended to improve access to culturally responsive care, increase a sense of belonging for clients, improve health outcomes and reduce disparities in access to care.

- TGI Trainings will take place September November 2025: 3 Live Virtual and 1 in-person; thereafter on SAPC LNC; continuing education credits will be provided.
- All provider staff that have direct contact with clients must complete training by March 31, 2026.
- New staff must complete within 6 months of onboarding.

YOUR RIGHTS

Substance Use Disorder Treatment

As someone who lives in Los Angeles County and is eligible for Medi-Cal or My Health LA, or other select County programs, you have a right to receive medically necessary substance use treatment services from the County and its network of providers, at no cost to you.

You also have the right to:

- Be treated and receive care with dignity and without discrimination based on your race, national origin, ethnic group identification, age, mental ability, physical ability, medical condition, religion, gender identity, or sexual orientation.
- Participate in decisions about your substance use care, including the right to refuse treatment.
- Be free from verbal, emotional, sexual, or physical abuse.
- Receive written materials critical to your care in other formats (such as other languages, large print size, braille, and audio), upon request.
- Receive treatment in a safe and healthful environment.
- Have your health information kept protected and private.
- Receive services in a manner that respects and acknowledges the impact of language, culture, and abilities on the individual.
- Request and receive a copy of your medical records, and request that they be amended or corrected as specified in 45 CFR §164.524 and 164.526.
- Receive oral interpretation services in your preferred language.
- Receive access to medically necessary services out-of-network, if the County does not have a provider who can deliver the services.
- Make a complaint, verbally or in writing, to the facility where you receive your care or to the County and receive a response.
- Request an appeal if you receive a Notice of Adverse Benefit Determination (or NOABD).
- Exercise these rights without it negatively affecting the services you receive.

42 CFR Part 2 Final Rule (2024)

42 CFR Part 2 Final Rule 2024 overview

- 42 Code of Federal Regulations (CFR) Part 2 Confidentiality of Substance Use Disorder (SUD) Patient Records (Part 2), is the federal regulation that restricts the disclosure and use of patient records maintained in connection with the performance of any federally-assisted substance use disorder (SUD) treatment program.
- On February 8, 2024, the U.S. Department of Health & Human Services (HHS) SAMHSA and the Office for Civil Rights announced a final rule modifying the Confidentiality of SUD Patient Records regulations, 42 CFR Part 2.
- > That implement changes required by CARES Act (2020) to align certain aspects of Part 2 with HIPAA
 - HHS factsheet on Final Rule
- > Key dates:
 - Effective date: April 16, 2024
 - Compliance date: February 16, 2026





What <u>did not change</u> with the 42 CFR Part 2 Final Rule 2024

Definition of Part 2-covered program

- Federally assisted program offering SUD services, defined in § 2.11
- Clients must consent in writing before their Part 2 records are disclosed, unless an exception applies
 - No major changes to exceptions

Concept of "lawful holder" now defined in § 2.11

 An individual or entity who has received SUD record(s) as the result of a Part 2 compliant consent with an accompanying notice of disclosure.

Court order requirements

• A subpoena or a similar legal mandate must be issued to compel use or disclosure





What changed with the 42 CFR Part 2 Final Rule 2024

Client Consent and Disclosures

- Allows for single written consent to disclose TPO
- Requires a separate written consent to disclose SUD counseling notes* -or- for legal proceedings against the client

Privacy Notices

- Updated the Notice to Accompany Disclosures
- Aligns the Notice of Part 2 Program's Privacy Practices (NPP) with HIPAA NPP requirements

New Client Rights

- Right to request an accounting of disclosures made with consent
- Right to request restrictions on disclosures of records
- Security and Enforcement
 - Aligns notification requirements for breaches of Part 2 records with HIPAA requirements
 - Requirements for receiving and responding to client Part 2 complaints
 - Updated penalties and enforcement by HHS



SAPC Efforts

- SAPC will release an Information Notice with needed actions to confirm compliance
 - Timeline for release early Fall 2025
- Update workflows and forms to comply consent, notices, and client rights requirements
 - Update Part 2 compliant consent form (aka Release of Information) to comply with Final Rule
 - Establish workflows with Department partners and stakeholders
 - Update *Notice of Privacy Practices (NPP)*

Consideration for Network Providers

- Review 42 CFR Part 2 Requirements
- Implement/revise workflows to comply with new requirements
 - Incorporate new actions for communicating Part 2 client consent
 - Workflows for including a copy of the signed consent and *Notice to Accompany Disclosures* when sharing Part 2 information.
 - Update existing *Notice of Privacy Practices (NPP),* include client acknowledgment
- Update/revise policies and procedures (P&Ps)
- Ensure all staff are trained on changes to disclosure and redisclosure
- Ensure compliance with breach notification obligations
 - Address the new breach notification requirements to maintain compliance

Compliance date: February 16, 2026
