Collateral Caller Workflow  SAPC-Learning and Network Connection Platform (SAPC- LNC)	<ul> <li>Antonne Moore (SAPC) provided an update on the SASH Collateral Call expansion, which allows individuals such as social workers, outreach workers, family members, and others to schedule SUD treatment appointment on behalf of clients, without clients being present. SASH agents are available to assess eligibility, determine the level of care, and schedule appointments. A tracking process is being developed to assess the success of these referrals.</li> <li>Dr. David Hindman, SAPC</li> <li>Dr. David Hindman introduced the SAPC Learning and Network Connection Platform (SAPC-LNC), a new learning management system designed to support public health initiatives and provide 24/7 access to CE-certified clinical trainings (including ASAM-A &amp; ASAM-B) and other resources, for the provider network at no cost. It includes on-demand learning, and live and recorded trainings. All registered SAGE users will be automatically enrolled for access. SAPC is recruiting five agencies to pilot the platform before full launch in April. Participation requires two meetings and platform testing. Reaching the 95% (R95) Initiative  Expansion of SASH	<ul> <li>Vanessa Lâm, SAPC</li> <li>Vanessa Lâm inquired about feedback and barriers in participating in the R95 initiative. While the first fiscal year saw strong engagement, participation declined in the second year with fewer agencies opting in.</li> <li>Jonathan Higgins (Beacon House) expressed that they already have policies that do not require abstinence, but concerns exist around messaging and how they communicate policies to clients.</li> <li>Dr. Tsai reiterated the importance to maintain a balanced approach—integrating low-barrier harm reduction and abstinence-based methods—as necessary for effective treatment.</li> </ul> Antonne Moore, SAPC

	<ul> <li>Katherine Li provided updates on the Behavioral Health Services Act (BHSA) planning sessions between DMH and SUD providers. She discussed recruitment efforts for the Community Planning Team to fill 32 seats to represent individuals with lived experience, including frontline workers, family members, or partners of those impacted by SUD. The commitment involves two meetings per month (one in-person, one virtual), with a stipend available for participants.
