In alignment with the passage of Senate Bill 803 (SB 803), the California Department of Health Care Services (DHCS) recognizes certified Medi-Cal Peer Support Specialists as a new Medi-Cal provider type and Peer Support Services as a Medi-Cal benefit, effective July 1, 2022. [California Mental Health Services Authority](#) (CalMHSA) is the certifying entity for the state-approved Medi-Cal Peer Support Specialist Certification (PSSC) program.

- **Certified Medi-Cal Peer Support Services (CMPSS) are culturally competent individual and group services delivered by Certified Medi-Cal Peer Support Specialists.**
- **These services augment the SUD treatment services patients receive by promoting:**
 - **Recovery**
 - **Resiliency**
 - **Engagement**
 - **Socialization**
 - **Self-sufficiency**
 - **Self-advocacy**
 - **Development of natural supports**
 - **Identification of strengths**
- **CMPSS are provided through structured activities such as group and individual coaching designed to set and make progress toward recovery goals.**

All candidates are required to fill out an application to take the certification exam.

1. Must be at least 18 years of age
2. Posses a high school diploma or general equivalency degree (GED)
3. Self-identify as an individual with lived-experience with the process of recovery from a mental illness or substance use disorder, either as a consumer of these services or as the parent, caregiver or family member of a consumer
4. Have a strong dedication to recovery and is willing to share their own experience of recovery
5. Agree in writing to adhere to the [Medi-Cal Code of Ethics for Peer Support Specialists](#) in California
6. **Complete the training requirements for a peer support specialist**
 1. **Training must be from a CalMHSA approved training entity. Click [here](#) for a list of approved training entities.**
7. Pass the state certification exam for Medi-Cal Peer Support Specialist Certification

Application Process Preparation



- **Plan to set aside at least 50 minutes to complete the application**
- Application time breakdown:
 - 5 minutes for registration
 - 30 minutes to watch the mandatory introduction video
 - 10-15 to upload all the necessary documents

The following documents must be uploaded in jpeg, jpg, or pdf format only:

- ✓ Proof of identification (government issued ID, driver's license, passport)
- ✓ High school diploma, GED or any other advanced degree

Application Process Best Practices



- ❑ Create a new empty file folder on your desktop, as you find them, to place required documents to be uploaded to your application
- ❑ For the [CA Peer Certification](#) website save your log-in information and make sure to log-in with the same information each time
 - Right below the log-in you can click “Don’t remember your password?” for assistance

- ❑ Once registered you are required to confirm your email. Make sure to go to your email inbox and confirm.
- ❑ Notifications from CalMHSA will be sent to the email you provided
- ❑ Application revision requests
 - Applicants will be notified at least one (1) time within the thirty (30) calendar day processing time from the time the application was submitted
 - The notification will include information on what needs to be revised
 - Incomplete applications will be held by CalMHSA for ninety (90) calendar days after date of submission
 - Those that remain incomplete will be voided, fees forfeited, and will require submission of a new application, documentation and fees.



Exam Information



When do I need to take the exam by?

- 12 months from your scholarship date of approval to take your exam
- To find out your date of approval:
 - Look for an email from CalMHSA with this info
 - Log into your CalMHSA [profile](#)
 - For questions, email peercertification@calmhsa.org
- If your date of approval was before December 18, 2022, then you have an automatic extension to take the exam BEFORE December 18, 2023.

Peer Support Specialist Certification Exam



[Peer Support Specialist Certification Exam - CA Peer Certification](#)

The Medi-Cal Peer Support Specialist (PSS) Exam is 2.5 hours with 120 multiple choice questions

Offered through on-line proctoring or in-person testing centers

Results of the exam are provided immediately after taking the exam either in person or on-line

Approved candidates can take the exam up to 3 times during the 12-month approval period

- The PSS Certification exam is administered by CalMHSA with third-party proctoring by Pearson VUE
- On the day of the exam, candidates must provide a valid, government-issued photo ID matching first and last name of letter of approval

On-line (live proctoring)

- Encouraged to use personal computer
- Review the [Online Exam Instruction Guide - CA Peer Certification](#) prior to testing
- Watch [this short video](#) to learn what to expect for testing on-line
- You'll be asked to take a photo of yourself, your ID and your testing area
- Must have an operational webcam, so that the proctor can see you at all times during the exam

- CalMHSA can take **up to 30 days** to review requests and will respond to candidates via email

Canceling, Rescheduling, & Missed Exams

- **On-line (live-proctoring) exam:** can cancel or reschedule exam up to **one hour before** your scheduled appointment
- **In-person testing center:** can cancel or reschedule exam up to **48-hours before** your scheduled appointment
- If you miss cancellation window, you forfeit entire exam fee and will be considered a no-show
- If you miss your exam, you won't be able to reschedule until you submit a retake request and pay the associated fees to CalMHSA

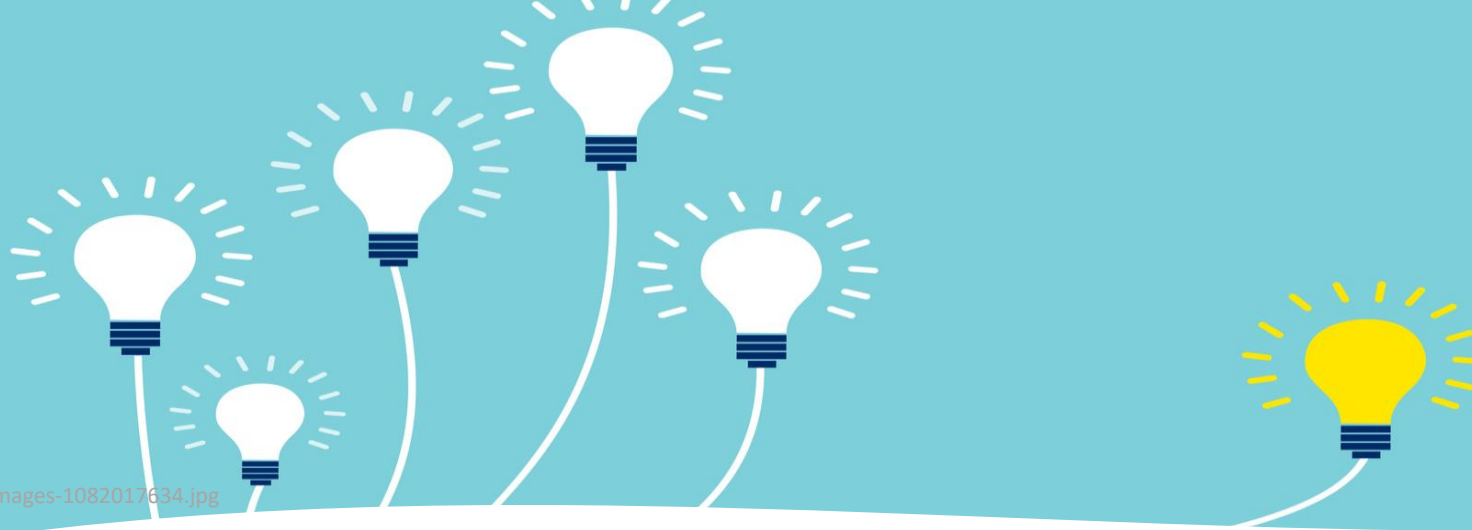

After you’ve finished, go back and check your answers

Test Taking Reminders

- Trust your gut – You know more than you think you do!
- Use positive self-talk
- Don't forget to breathe – practice taking deep breaths you can use before, during and after test
- Get plenty of rest
- Stay hydrated and eat foods that can reduce stress and help you keep a calm stomach



Certification Renewal & Continuing Education (CE) Requirements



CalMHSA will notify certified Medi-Cal Peer Support Specialists ninety (90) days prior to date of expiration via email.

1. **Recertification is required every 2 years to maintain certification.**
2. Applicants must complete 20 hours of continued education prior to submitting the recertification application.
3. [Fees](#) must be paid at the time of submitting the application.
4. Application must be submitted online through the certification website.
5. Application must be submitted prior to date of expiration. Certifications are considered to expire immediately following the two-year expiration date from the last date of issuance.
6. Applications may be submitted up to 60 days prior to expiration.
7. Applicants must have a current and valid Medi-Cal Peer Support Specialist Certification in good standing.
8. Applicants must read and re-sign agreements to adhere to the Code of Ethics for Medi-Cal Peer Support Specialists in California.
9. Applicants attest to having met the twenty (20) hour of continued education requirement, inclusive of the six (6) hours of continued education in law and ethics.
10. Applicants shall maintain records of continued education hours for two (2) years from the date of request for renewal.

Continuing Education Requirements



- Must complete twenty (20) hours of continued education every two (2) years from the date of initial certification and thereafter for recertification.
- Included in the 20 hours a six (6) hour course on laws and ethics is required during each two-year cycle.

Continuing Education (CE) Hours

- Training courses offered by the following are accepted by CalMHSA:
 - Any CalMHSA-approved training provider.
 - County Behavioral Health Departments, and its contracted network providers.
 - Accredited schools, including vocational education.
 - Professional certification and licensing boards (i.e., CAADE, CADTP, CAMFT, BBS, APA, Mental Health America (MHA), SAMHSA etc.).
- Evidence of participation must include:
 - Legal name of the CMPSS
 - Title of course, training, and/or event
 - Date(s) of participation and/or course completion
 - Event sponsor and/or training provider name (i.e., SAMHSA)
 - Number of direct instruction hours
- Records should be maintained for a minimum of two (2) years from the date of application for renewal
